THE 2010 INDIANA INJURY PREVENTION CONFERENCE

Mark your calendars! The 2010 Injury Prevention Conference is scheduled for May 13th and May 14th in downtown Indianapolis. University Place Conference Center and Hotel will once again host the conference. The conference will again include two tracks for participants to follow. One track will focus on child restraint and vehicle safety issues. The second track will include topics on some of our most pressing injury prevention concerns. There will be two plenary sessions as well. The conference boasts some extraordinary speakers, so no matter what your injury prevention passion may be, you will find the conference to be a wonderful experience!

Participants can earn child passenger safety technician CEUs, as required for recertification, and law enforcement officers can receive credits for their attendance at the conference sessions as well.

The grants range from \$250 to \$1,000, and are determined based on your chapter's activity level in 2009. The funds must be used by September 30th.
